Many of the students in our Intern Program are either working in the School District of Philadelphia, or the low-resource school district of Chester-Upland. In the past our interns have gone on to be hired in these school districts.

Students are immersed in a variety of technology through hands-on activities and best practices. All activities are connected to the integration of technology in the classroom environment by discussion and observation. Students participate in the assessment process as both the student and the teacher. They collect data while evaluating each others' work and share these evaluations with the instructor and their peers. All technology learning activities emphasize the differentiation of instruction and the inclusion of the use of a variety of software and hardware to accommodate diverse students. We continue to expand the use of assistive technology and appropriate software in technology courses to emphasize the principles of universal design for all students.

In each of our program's methods courses, faculty address accommodations for learners with special education needs that are specific to the program or content area. The ED 5600-Literacy Instruction & Intervention for Learners with Diverse Needs includes a component for adapting and including reading strategies to meet the needs of special education students in the regular education classroom. Collaboration and Inclusion, and Literacy and Disabilities are core components of the Elementary and Early Childhood programs. ED 624 on the instruction of English Language Learners is offered every semester and is a required course.
